

# ASCMSALARY SURVEYPRIZE PROMOTION RULES, TERMS AND CONDITIONS

# Updated January 18, 2023

### PROMOTION DESCRIPTION.

In connection with ASCM's efforts to improve its salary report and related activities, ASCM is conducting this prize promotion sweepstakes ("Promotion") to increase awareness of ASCM's new salary survey. The Promotion is a prize drawing promotion that begins on January 23, 2023 at 08:00:00 AM CT and ends on February 14, 2023 at 11:59:59 PM CT ("Promotion Period"), and is subject to these Prize Promotion Rules, Terms, and Conditions ("Rules").

#### 2. ELIGIBILITY.

Open to legal residents of the fifty (50) United States and District of Columbia who: (a) are 18 years of age or older at time of entry, and (b) who complete the salary survey by February 14, 2023 at 11:59:59 PM CT. No purchase is necessary to participate. Void where prohibited. The Promotion is not open to employees or immediate family members of ASCM, and other participating partners in the Promotion.

# WINNER SELECTION:

There will be five (5) random prize drawings held on March 3, 2023 for all qualified online entries from 08:00:00 AM CT on January 23, 2023 through 11:59:59 PM CT on February 14, 2023. Incomplete entries will not qualify to be entered into the contest. Potential winner will be selected in a random drawing from all qualified entries received. Odds of winning based on the number of entries received. Purchases do not increase the odds of winning.

Potential winner will be notified by email and/or by phone. Potential winner will have three (3) days to respond with their complete mailing address and interest to become the winner or an
